

Sanitary and Improvement District Elections

Election Day is Tuesday, September 13, 2022.

Filing deadline is July 25, 2022 (fifty days prior to the election). Applications may be obtained from the Sarpy County Election Commission office and may be notarized by a Notary Public and returned to the election office by July 25th at 5:00 P.M. Filings are also taken in person at the Election Office. No filing fee is required. When filing, the candidate shall designate on which ballot their name shall appear. The name shall appear on only one ballot.

Write-in candidates may be elected to office, however, the box appearing in front of the write-in name must also be marked. Such trustees shall be owners of real estate located in the district or a designated representative of an entity that owns real estate in the district.

Deadline to file: 50 days prior to election. (July 25, 2022). No filing fee required. Filing must be in Election Office, 1102 E 1st St Ste 1, Papillion, NE 68046 by 5:00 P.M.

*If the name of the person filing does not appear on the deed, verification of property ownership must be presented at the time of filing.

**For a designated representative of a limited partnership, limited liability company, public, private or municipal corporation, estate, or trust which owns real estate in the district, the filing shall indicate that fact and shall include appropriate documentation evidencing such fact.
